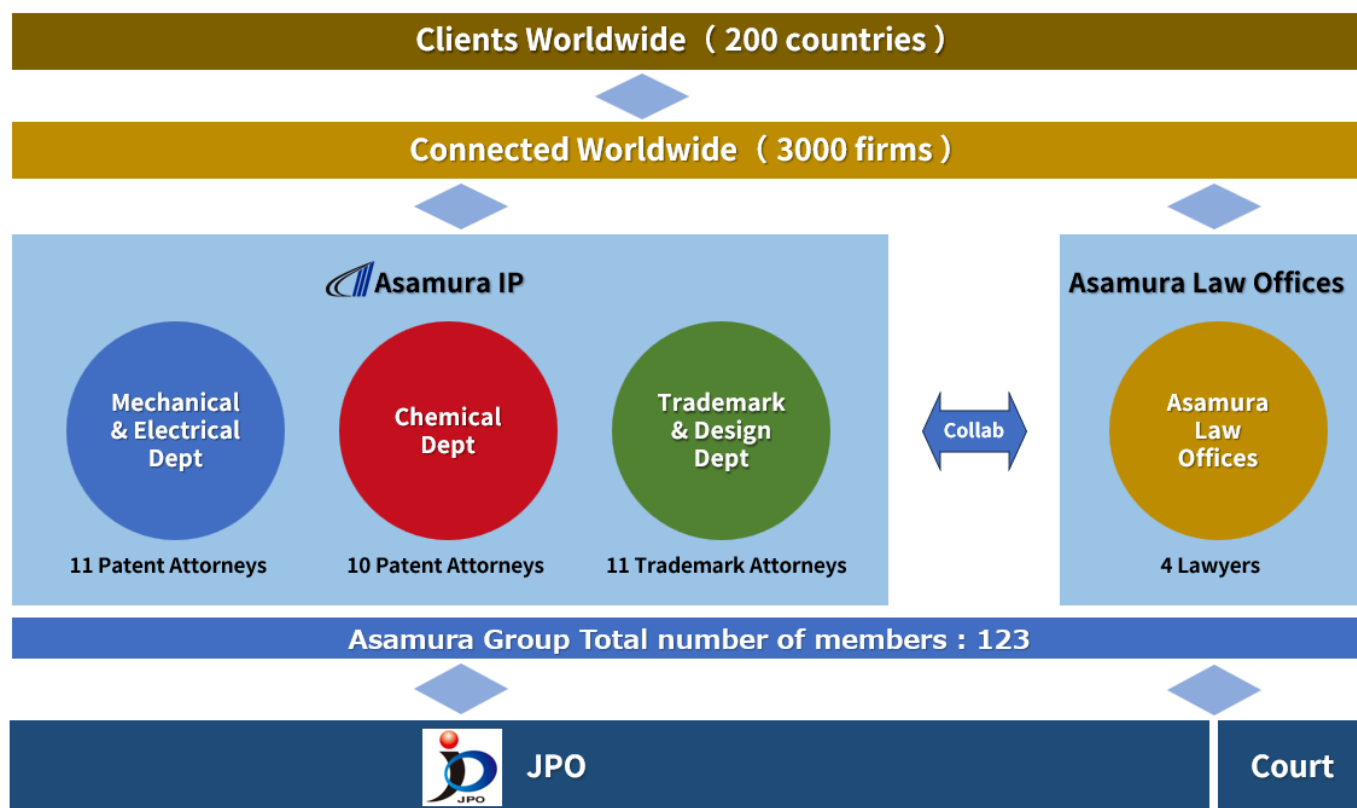

Foreign filing through local agents in various IP-related procedures before foreign patent offices and courts on behalf of domestic clients.

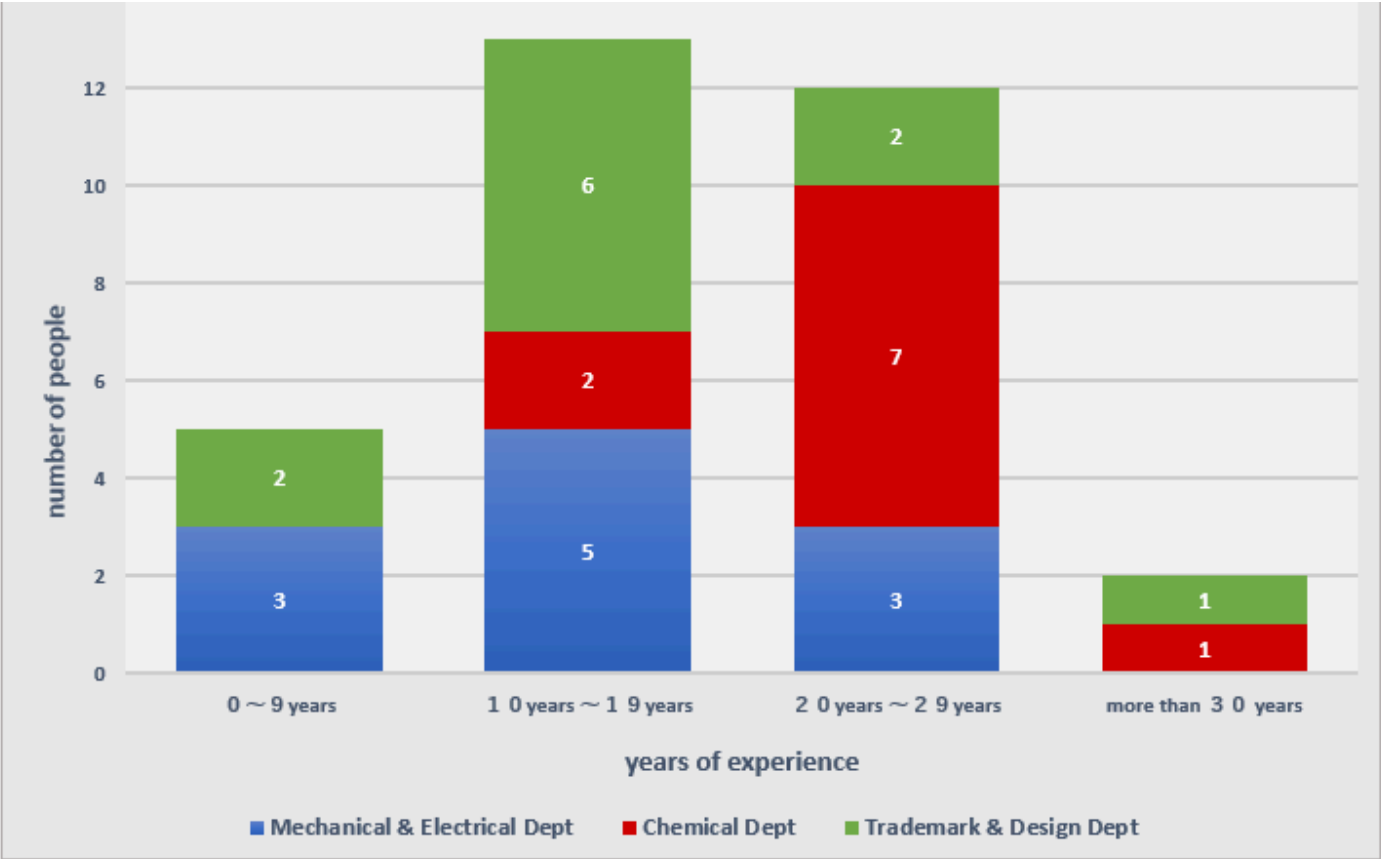

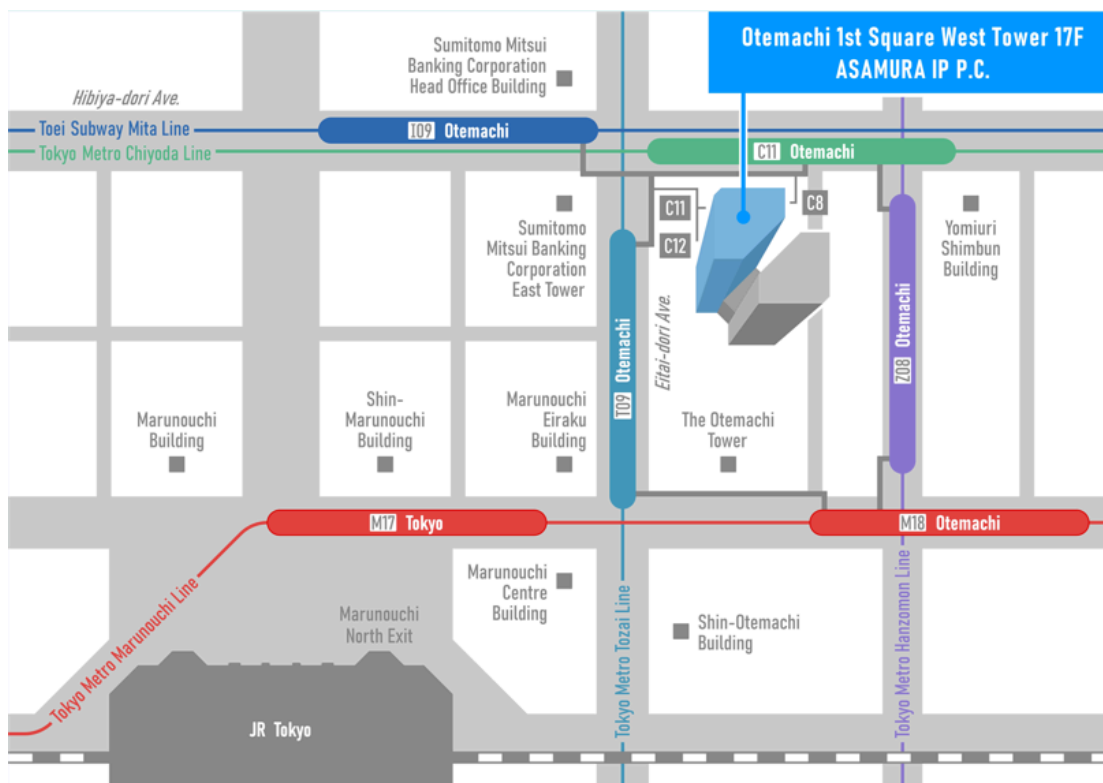
# Saburo Asamura with Mr. Korekiyo Takahashi
